Community Center Request

The board discussed the request from HWF, Historic Wilmington Foundation to use the center on Oct 19th but realized it was the scheduled meeting night. The clerk will contact the representative about the scheduling conflict.

PARKS AND RECREATION

Mayor Willis informed the Governing Board that the Parks and Recreation is requesting an uplift to both parks. Request that council give them a maintenance plan if not the parks and recreation board would like to develop one.

Councilman Ballard spoke about the plan that was previously submitted for Phoenix Park Water installation stating that the plan wasn't what the citizens in that district wants.

A discussion was held with the Mayor stating he was trying to assist with the project until Councilman Ballard was available to head up project.

Councilman Everett suggest allowing the parks and recreation board getting the necessary estimates for water installation for Phoenix Park and presenting it to the Town Board.

A request for Magnolia Drive Park to do a wet water park this will intel getting a landscape architect conceptual plan. Requesting permission to send out RFQ for landscape architect.

Councilman Merrick asked would the stormwater be included with the project. Mayor will have landscaping architect speak with the NCEM Grant representative.

Councilman Everett asked about the feasibility of having this done on a dead-end road, Mayor spoke to the board about the road that is located on the back side of Champ Branch that could be connected as another outlet.
